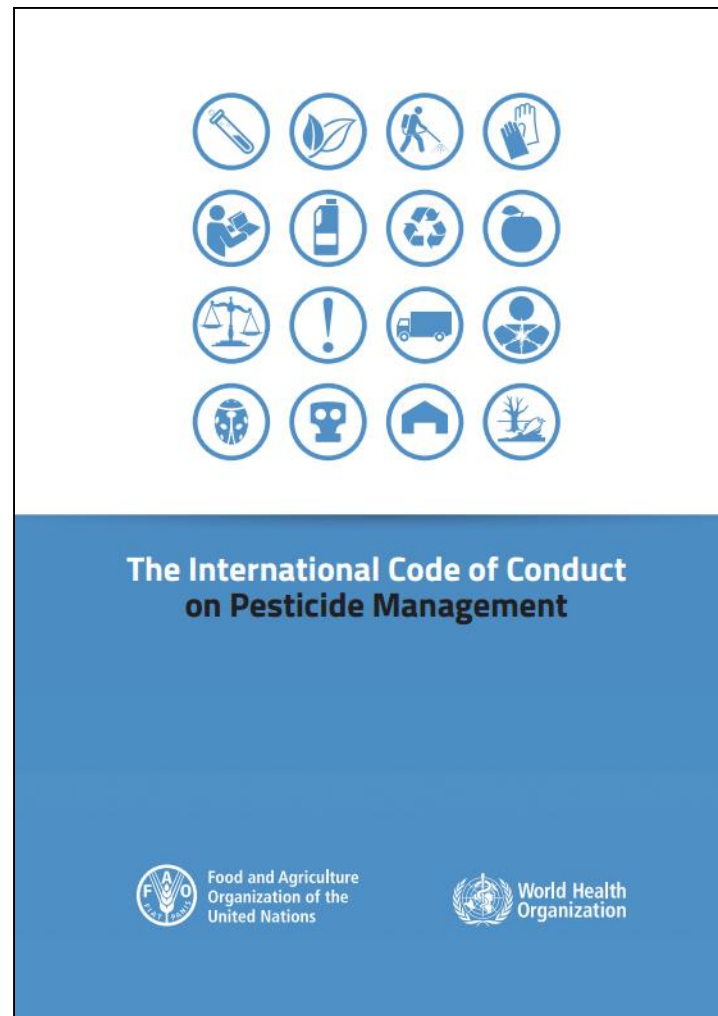


New e-Learning Tool to Help Navigate International Code of Conduct on Pesticide Management

Facts about the Code

- Developed in 1985 by the United Nations Food and Agriculture Organization (FAO)
- Based on risk assessment and shared responsibility of all parties in the manufacturing and handling of pesticides
- Supported by global CropLife network
- Updated in 1989, 2002, 2009 and most recently, in 2013



What are the latest updates to the Code?

- Changed name from “International Code of Conduct on Distribution and Use of Pesticides” to “International Code of Conduct on Pesticide Management”
- New and/or amended definitions for active ingredient, co-formulant, container, pesticide, pest, pesticide management, public health uses of pesticides, lifecycle, poison, vulnerable groups and Highly Hazardous Pesticides (HHPs)

What are the latest updates to the Code?

- New focus on Highly Hazardous Pesticide (HHP) risk management (that is consistent with [CropLife International's approach to HHPs](#))
- Introduction of new areas of focus such as Integrated Vector Management (IVM), Pest Control Operators (PCOs), International Organization and Severely Hazardous Pesticides Formulations

What are the latest updates to the Code?


- Encouragement of policies, regulations, permits and licenses as well as information exchange for PCOs
- A greater attention to health and environmental aspects of crop protection products
- Aligns guidance in several technical areas with developments in international chemicals management

What are the latest updates to the Code?

- More information about Globally Harmonized Systems, counterfeiting and illegal trade
- Updated listing of international agreements relevant to the Code

What are the changes to the e-learning tool?

- The content reflects the latest changes in the Code
- New easy-to-use design
- Sign-up mechanism saves information for returning users and helps measure use of the tool

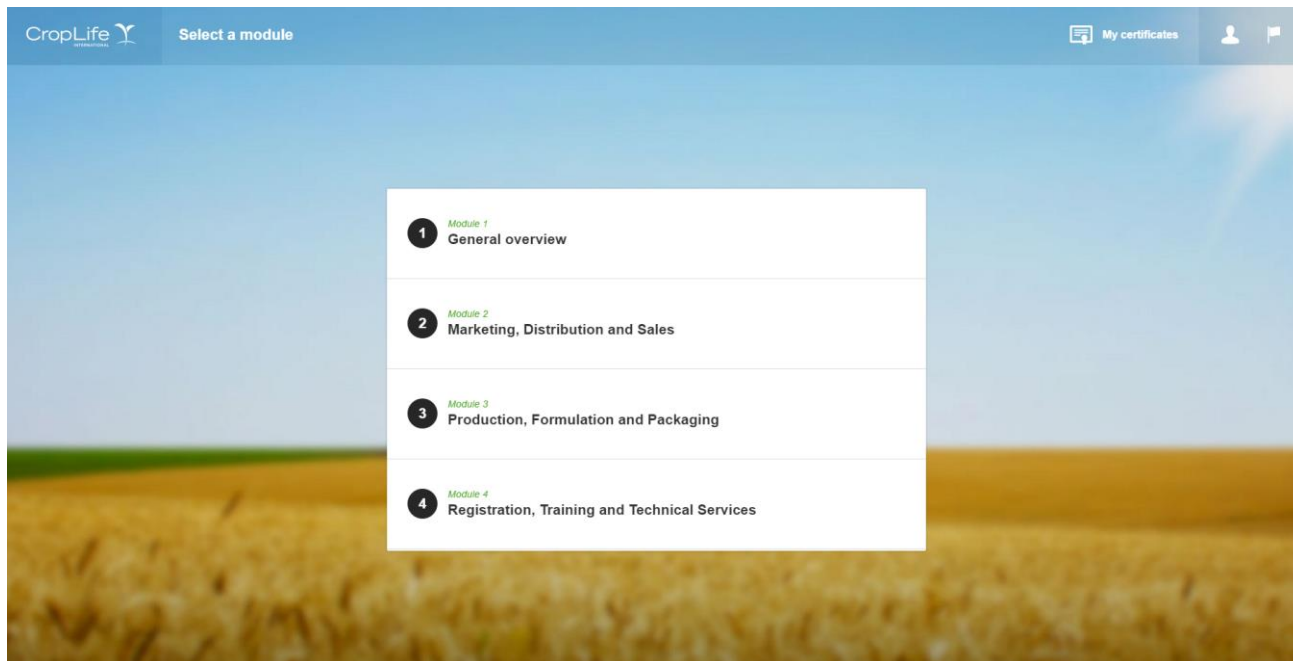
